This Schedule 13G is being filed on behalf of (i) Mitchell P. Kopin, an individual who is a citizen of the United States of America (“**Mr. Kopin**”), (ii) Daniel B. Asher, an individual who is a citizen of the United States of America (“**Mr. Asher**”) and (iii) Intracoastal Capital LLC, a Delaware limited liability company (“**Intracoastal**” and together with Mr. Kopin and Mr. Asher, collectively the “**Reporting Persons**”).

The Reporting Persons have entered into a Joint Filing Agreement, a copy of which is filed with this Schedule 13G as [Exhibit 1](#), pursuant to which the Reporting Persons have agreed to file this Schedule 13G jointly in accordance with the provisions of Rule 13d-1(k) of the Securities Exchange Act of 1934, as amended.

(a) and (b):

(i) Immediately following the execution of the Securities Purchase Agreement with the Issuer on March 19, 2020 (the “**SPA**”) (as disclosed in the Form 8-K filed by the Issuer with the Securities and Exchange Commission on March 19, 2020), each of the Reporting Persons may have been deemed to have beneficial ownership of 2,039,408 shares of Common Stock, which consisted of (i) 952,377 shares of Common Stock to be issued to Intracoastal at the closing of the transaction contemplated by the SPA and (ii) 1,087,031 shares of Common Stock issuable upon an exercise of a warrant held by Intracoastal (“**Intracoastal Warrant 1**”), and all such shares of Common Stock in the aggregate represent beneficial ownership of approximately 9.99% of the Common Stock, based on (1) 18,375,095 shares of Common Stock outstanding as of March 18, 2020 as reported by the Issuer, plus (2) 952,377 shares of Common Stock to be issued to Intracoastal at the closing of the transaction contemplated by the SPA and (3) 1,087,031 shares of Common Stock issuable upon an exercise of Intracoastal Warrant 1. The foregoing excludes (I) 1,770,111 shares of Common Stock issuable upon exercise of Intracoastal Warrant 1 because Intracoastal Warrant 1 contains a blocker provision under which the holder thereof does not have the right to exercise Intracoastal Warrant 1 to the extent (but only to the extent) that such exercise would result in beneficial ownership by the holder thereof, together with the holder’s affiliates, and any other persons acting as a group together with the holder or any of the holder’s affiliates, of more than 9.99% of the Common Stock, and (II) 6,450 shares of Common Stock issuable upon exercise of a second warrant held by Intracoastal (“**Intracoastal Warrant 2**”) because Intracoastal Warrant 2 contains a blocker provision under which the holder thereof does not have the right to exercise Intracoastal Warrant 2 to the extent (but only to the extent) that such exercise would result in beneficial ownership by the holder thereof, together with the holder’s affiliates, and any other persons acting as a group together with the holder or any of the holder’s affiliates, of more than 4.99% of the Common Stock. Without such blocker provisions, each of the Reporting Persons may have been deemed to have beneficial ownership of 3,815,969 shares of Common Stock.

(ii) As of the close of business on March 27, 2020, each of the Reporting Persons may have been deemed to have beneficial ownership of 1,656,450 shares of Common Stock, which consisted of (i) 1,200,000 shares of Common Stock held by Intracoastal, (ii) 450,000 shares of Common Stock to be issued to Intracoastal upon the closing of a transaction entered into with the Issuer on March 27, 2020 and (iii) 6,450 shares of Common Stock issuable upon exercise of Intracoastal Warrant 2, and all such shares of Common Stock represented beneficial ownership of approximately 4.6% of the Common Stock, based on (1) 28,434,895 shares of Common Stock outstanding as of March 25, 2020 as reported by the Issuer, plus (2) 7,450,000 shares of Common Stock in the aggregate issued at the closing of the transaction disclosed in the Form 8-K filed by the Issuer with the Securities and Exchange Commission on March 26, 2020, (3) 450,000 shares of Common Stock to be issued to Intracoastal upon the closing of a transaction entered into with the Issuer on March 27, 2020 and (4) 6,450 shares of Common Stock issuable upon exercise of Intracoastal Warrant 1.
